
#### **About Mitsui:**

### **Eligibility Criteria**



**Nationality:** Applicants shall be citizens of the Republic of India.



**Age:** Applicants shall be less than twenty (20) years of age as of April 1st, 2025, & unmarried.



#### **Academic Background & School Records:**

Minimum aggregate marks of 80% in HSC examination or SSC (in case appearing for HSC) of CBSE or ICSE board.



For Science background: Mathematics, Physics, Chemistry & English.



For Commerce background: Mathematics, Economics, Business Studies & English.



Japanese Language: JLPT N3 Certificate (If student has N4 clearance & preparing for N3 it may also be considered basis language proficiency)



**Health:** Please obtain a Character certificate from the school & a fitness certificate from a doctor.

# **Duration of Scholarship**



Japanese language study:
1.0 year (12 months) at
Japan Student Services
Organization, Tokyo,
Japan (JASSO)

University study: 4.0 years (48 months)



#### **Timeline**



#### JULY 2024

Interested candidates apply for the program.

#### NOV 2024

Selected candidates apply to Japan Student Services Organization (JASSO) for Japanese Language training course.

#### **NOV 2025**

Appear for EJU (Examination for Japanese University Admission for International Students)

#### **AUG-OCT 2024**

Candidates appear in selection process.

#### **APR 2025**

Students depart for Japan to study at JASSO.

#### **APR 2026**

Start graduation course at Japanese university.

#### **Benefits Offered**



**Living Allowance:** JPY 145,000/month



Transportation Charge: An economy class one-way air ticket from New Delhi to Tokyo and back to New Delhi upon applying, within 1 (one) year after the expiration of the scholarship provision.



**Arrival Allowance:** One time JPY 50,000



**School Fees:** Complete tuition fee of Japanese language training centre and University



Insurance: Travel insurance, & accident insurance for the Grantees during the period of Scholarship approved by the Program, shall be borne by the Program. (National health insurance premium in Japan shall be borne by the Grantees.



# Accommodations, Meals, Local Transportation & Other Costs & Expenses:

- 1st Year: Lodging subsidy of JPY 5,000/month for dormitory stay at JASSO.
- ◆ 2nd-5th Year: JPY 25,000/month to arrange stay during university study.
- ◆ The cost of textbooks is included in the scholarship
- Meals, local transportation charges and other expenses are not included in the scholarship

### **Subjects Allowed Under this Program**



(a) Study of Sciences and Engineering (4-years under-graduate course), such as;

Mathematics, Physics, Chemistry, Information & Computer Science, Biology, Biophysics & Biochemistry, Geology, etc.	Civil Engineering, Architecture, Urban Engineering, Environmental Engineering, etc.
Mechanical Engineering, Precision Engineering, etc.	Ship Building & Ocean Engineering, Aeronautics, etc.
Electrical Engineering, Electronics, Information & Communication Engineering, etc.	Industrial Engineering, Factory & Production Management, Plant Management, etc.
Applied Chemistry, Chemical Engineering, etc.	Metallurgy, Materials Science, etc.
Agricultural Engineering, Forest & Fishery Science, Agricultural Chemistry, Agro biology, Food Engineering, etc.	

Due to course term reason, applicants are not entitled to choose Medical science, Pharmaceutical science and Veterinary science as field of study.

(b) Study of Social Sciences, Business and Commerce (4-years under-graduate course) such as;

Economic Theory, Economic History, Economic Policy, etc.	Civil Law, Public Law, Political Science, etc.
Enterprise Management, Accounting, Commerce & Marketing, Finance, Insurance, Industrial Relations, Econometrics, International Economics, etc.	

# **Duties during Scholarship Program**

- Grantees must submit academic records and periodic status reports to the Program.
- Grantees shall participate in meetings to report updates held by the Program.
- Grantees cannot work or earn profit during their stay in Japan without prior written approval from the Program.
- Social engagement with Mitsui and other grantees to discuss the scholarship's impact and feedback.

# Placement at Universities in Japan & Major Fields of Study

- Grantees shall indicate their preferred university & field of study for Program approval. Admission must be secured by the grantee based on their performance in the entrance exam.
- Change of major or field of study after entrance to a selected university shall not be allowed.
